## The Carers Card



Our carers card service includes a separate account that is set up specifically so that carers can access small amounts of money to make everyday purchases or withdraw cash. This protects both the carer and the person they care for.

## Fully Managed Service

This is a **fully managed** service where our team can liaise directly with carers, care managers, family members and the client directly, to order replacement cards, confirm balances and also to provide an additional layer of support and oversight.

## Secure and Convenient

Our carers shopping card service is provided securely through The Money Carer Foundation's company banking platform via its banking provider and the international Mastercard payments network.

## How Does It Work?



The carer cards enable carers to make purchases in shops or online in exactly the same way as any other Mastercard. The cards are issued in the name of the carer with their own PIN number for their protection and that of the vulnerable person they care for.

New and replacement cards are ordered by the cards team at The Money Carer Foundation and sent to an agreed address for the carers to receive them. The carer can then let us know that the cards have been received and we will then activate the cards and they will be ready to use.

This is a fully managed service and we are here to support carers and clients with balance enquiries, ordering new cards and arranging statements when necessary.
